# Transition from

# GLOBALG.A.P. IFA v5.4-1-GFS and IFA v5.2 to IFA v6-GFS and IFA v6-Smart

Integrated Farm Assurance (IFA) version 6 for fruit and vegetables and aquaculture was published in 2022; being two parallel editions: IFA v6 SMART and IFA v6 GFS, the latter intended for producers who require a certification with GFSI recognition.

Derived from the recent GFSI recognition for IFA v6-GFS last August, a transition period has been confirmed.

### Transition period:

- GFSI recognized IFA v6-GFS on August 6, 2024 •
- Audits conducted under IFA v5.4-1 can still be carried out until December 31, 2024.
- Certificates issued under IFA v5.4-1 remain valid for the lifecycle referenced in the certificate.
- As of January 1, 2025, all audits under IFA for aquaculture, fruits and vegetables must be carried out against IFA v6 SMART or IFA v6 GFS
- No audit under IFA v5.4-1 shall take place after January 1, 2025.

On the other hand, the audits for the sub scopes: Propagation Material and Combinable Crops shall continue being carried out under IFA v5.2. (It should be noted that a new version regarding these subscopes is under development, so this point is subject to changes until further notice)

### Certificate Issuance:

- Certificates will be issued at the scope level; this will list the applicable product categories individually.
- Certificates issued under IFA v5.2 will remain valid until a transition period for the Propagation Material and Combinable Crops subscopes is announced.
- When an organization achieves certification in the IFA v6 Smart edition and wishes to apply the IFA v6 GFS edition in its surveillance, the validity dates already established in the initial certification period must be maintained.
- When the initial or transition (recertification) audit/inspection on version 6, either Smart or GFS edition is completed, Global Standards will issue the certificate in the new GLOBALG.A.P. IFA v6 version.

#### Communication with customers:

By the transition process, Global Standards considers the following forms of communication with clients:

- 1. Webinar (informative, lectures on the main changes).
- 2. Notices (sent by email to all certified customers).
- 3. Website (transition rules, releases, and FAQs).

To validate the effectiveness of communication, Global Standards will monitor users' frequently asked questions on the website.

All transition process requirements described in this release are based on GLOBALG.A.P. requirements; however, there may be additional requirements set by Accreditation Bodies.
